NOTICE OF MODIFICATIONS TO TEXT OF PROPOSED MODIFICATIONS TO FAIR EMPLOYMENT AND HOUSING ACT FAIR HOUSING REGULATIONS

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Civil Rights Council (Council) is providing notice of modifications to the text of proposed modifications to sections 12040, 12140.1, and 12141 of Title 2 of the California Code of Regulations covering the Fair Employment and Housing Act. These changes are attached and made in response to written comments to proposed regulations received during the first 45-day public comment period that ended April 3, 2023.
