Park at West Parking Structure for the Kroc Institute for Peace and Justice:

Enter campus through the West Entrance. From the West Entrance, follow the road (Marian Way) to the second stop sign. Make a left into the West Parking Structure.

Please pay for parking at one of the pay stations or on the [ParkMobile app](#).

- The rates for parking in metered areas are \$2.50 per hour and \$18.00 for the full day. The pay stations on campus accept coins as well as Visa and Mastercard credit/debit cards. **Pay stations do not accept cash or American Express cards.**
- All paid parking areas at USD operate as pay-by-plate. This means that a license plate number is required when making a payment at the pay station. It may be helpful to take a picture of your license plate after you park your vehicle. **Once you have made your payment, there is no need to display your receipt on your dashboard.**

Tram Service: USD trams are available in the West Parking Structure to take guests to the Kroc Institute for Peace and Justice. The tram runs every 5 to 7 minutes. A complete tram schedule is available on the [Tram Services Website](#).
